1 Introduction:

SDG 16 speaks about peace, justice and strong institutions. The prevalence of peace and justice cannot be ignored as it constitutes one of the prime criteria for building up a very strong institutions. Peace and Justice are complimentary to each other both are very much vital for providing equality among human beings and nations. Justice could be individual to collective. For example, slavery, human trafficking etc. KIIT is one of the premier institutions which emphasizes on ensuring peace and justice in the campus & beyond. There are students and employees from different parts of the globe. Therefore it is the one of the prime concerns of the management.

The University has a strong governance system and provides out-most importance to governance and leadership for smooth functioning and continuous growth of the University in proper direction. The Vice Chancellor is the Executive Head of the University who also acts as Chairman of different Committees

constituted under the University. The University follows well-structured decentralized governance system. It maintains intense transparency in governance with active participation of all its stake holders. All departments/ schools are independent autonomous in academic and matters: Accountability is ensured by internal audit as well as through department level academic monitoring committee. There is representation of all its stakeholders like students, faculty, parents and alumni as well as academicians and industry personnel of repute in all its major policy making bodies. Feedback from stakeholders plays a major part in all developmental work carried out in the University. Research work are undertaken on peace and justice: There have been extensive research carried out by the academicians of the institute on this topic.

- Emphasis on non discriminating and crime free society


3 Policies and Initiatives:

Different policies and initiatives of the University in this regard have been highlighted below:

a) University governance system:

The University has a strong yet transparent governance system approved by the University Grants Council (India), which is the chief authorizing agency for the University. The University has well defined policies procedures to identify stakeholders external to the University and engage with them. This includes representation of stakeholders in major decision making bodies University and in its Governance. The University, as part of its policies and procedures appoints academicians, industry personnel and other local stakeholders as external members of in its major decision making bodies like Board of Management, Council, Academic Board of studies. International Quality Assurance. There is representation from existing students, alumni and parents also in all its major policy making bodies. Student Council has been a important part of the University looking into the student welfare and bridging the gap between the management and the students. Additionally, all stakeholders including the alumni, parents, reputed academicians, representatives from

industry and employers are involved in providing feedback on the curriculum, framing of course/student outcomes and program educational objectives.

b) Academic freedom policy

Academic freedom is provided to the students, faculty and other staff members. Faculty members are allowed to choose their topics of interest for teaching and research. They are provided freedom to collaborate with

academic institutions, and academicians of their choice. Freedom to float courses in collaboration with industry partner and establishing centre of excellence. They are empowered to provide consultancy services in collaboration with industry and other government agencies. Faculty members are provided with option for providing free educational resources and lectures through designated portals.

Faculty members and research students deliver talks on their choice of research topic on weekly basis in different schools of the University which is open to attendance of any member of the University and general public. Students are provided freedom to choose subjects from other streams across programmes of the University under the choice based credit system.

Other staff members are also encouraged to opt for higher studies in their stream of interest. They are provided with freedom to publish papers and deliver talks in their fields of choice.

c) Advising the Government

The University is involved in expert opinion and advice through its involvement with a horde ornational and international organizations under the umbrella associations and councils. The University is member Indian Science Congress Association, Indian Commerce Association, Indian Society for Technical Education, Indian Social Science Congress, Khelo India Organisation and Association of Indian Universities (AIU) to name a few.

Academicians of the University are members of different policy making bodies and those working under the aegis of the Government of India.

The University has been nominated as a mentor institute under the 'Paramarsh National scheme' of Assessment Accreditation Council to extend support to those institutions awaiting for accreditation in different stages. Eleven colleges and one University have signed their MoU with KIIT to be its mentee institutions.

an initiative of the University KIITTBI, supported by Department of Science & Technology (DST), Government of India offers facilities incubation and enables the incubatees to work in a secure, innovative and entrepreneurial environment as they through progress various stages entrepreneurial development. The Technology Business Incubator (TBI), established with the view to serve as an Incubator for potential entrepreneurs, serves as a focal point for entrepreneur development, patent support, They provide regular feedback and etc.



d) Participation in Government research

The University is involved in a large number of policy focused research in collaboration with government department/ organizations. More than 100 research projects in emerging areas and SDGs are going on in collaboration with government agencies like DST, DBT, BRNS, MNRE, ICSSR etc in areas of national and international relevance. Several research particularly those in collaboration with Indian Council for Social Science Research are based on various social issues leading to SDGs and are helpful in framing necessary policies. Various seminars, Conferences and events are organised in collaboration being government agencies with emphasis on policy focus research. e) Holistic development of the indigenous children

The University looks into the holistic development of the indigenous/ tribal students in collaboration with its sister concern Kalinga Institute of Social Sciences (KISS), Bhubaneswar, India. KISS is a fully free, fully residential home for 30000 poor indigenous/tribal children who are provided holistic education from kindergarten to post graduation along with lodging, boarding, health care facilities besides vocational, life skills empowerment. The University plans educate to 2.00.000 indigenous (tribal) children over the next decade and in the process of setting up branches in 10 states, with the support of respective state Governments, and in all 30 districts of Odisha.

Students are high achievers academics. co-curricular activities and national and international sports, making it a successful highly model of tribal empowerment through education. KISS has so far set up centers in Delhi, Mayurbhani, Balasore are currently functioning. More than 5000 students have already converted to mainstream of the society.

The School is fully supported by the Govt. of Delhi and managed by the Chief Executive Officer, KISS Delhi and his team very successfully.

Emami KISS Residential School is a joint with Group venture Emami (http://www.emamiltd.in/). Modeled along the lines of the original, innovative campus at KISS, it will function as a residential academic providing centre holistic education. accommodation, food, health care, study material and sports training to its students free of cost.

Recognizing the success of KISS model in Bhubaneswar, Bangladesh is all set to replicate a congruent version of it in Dhaka and Jessore. Branch at Dhaka is being set up in association with Daffodil International University, Dhaka. Jessore Branch is supported by 'Banchte Shekha', a leading NGO led by Dr. Angela Gomes, Ramon Magsaysay Laureate. KISS shall provide technical and managerial support for the functioning of the two branches.

A new branch of KISS is being established in West Bengal, in collaboration with 'Help Us Help Them', a Kolkata based NGO that promotes the same cause. The school shall be a residential school for over 1000 children and will have the same structural model as KISS.





g) University's commitment for crime free society

The University's principles and commitments on organized crime, corruption & bribery are being published as the part of the University Working guidelines.

The Clause 3.1 of Human Resource Manual that 'in the discharge of his/ her duties, no employee shall, except with the prior sanction of the competent authority, accept or permit his wife or any other member of his/ her family to accept from any person other than relatives any gift of more than trifling value. The interpretation of the term 'trifling value' shall be the same as laid down in the Government Servants Conduct Rules'

The University has also established both online and offline grievance and disciplinary committees in which Ombudsmen are also appointed, to resolve issues, if any arises. The

employee has to face strict action if found guilty of any crime including corruption & bribery.

h) Legal Aid and Assistance Clinic

KIIT Legal Aid and Assistance Clinic has been working in the campus with an aim to provide free legal aid services to any one and everyone who approached them.



i) Centre of Excellence

- i. The University has 24 centres of Excellnece in collaboration with industry and government agencies, working in various SDGs. The list of Centres along with their details are provided as Appendix IV.
- ii. k) Wellness Clinic

Wellness clinic has been established in the city of Bhubaneswar and is several districts of the state by the University supported by its medical unit. These clinics provide services associated with naturopathy treatment, counseling services, rehabilitation and deaddiction therapy. So far, more than 1500 people have been cured of mental tension and severe addiction.
