Sub: Invitation Letter regarding conduct of East Zone Inter University Basketball (M) Championship 2021-22 at KIIT – Deemed to be University, Bhubaneswar.

Respected Sir/Madam,

Greetings from KIIT Sports!!!

I wish to extend our hearty welcome to all the participating University of **East Zone Inter University Basketball (Men) Championship 2021-22 from 13th – 16th March 2022**. The detail information is attached, which may please be brought to the notice of the managers/Coaches accompanying the team.

1. **Kalinga Institute of Industrial Technology (KIIT)** is in the heart of the capital city Bhubaneswar. The City of temples Bhubaneswar is well connected with Flight, Train & Bus Services from all parts of India. Bhubaneswar Railway Station is about 13 Km far from University Campus. The University will provide transportation from Railway station to KIIT University Campus, if itinerary of the teams will be provided to us well in time.

2. **Accommodation** - As per AIU guidelines All will be provided furnished accommodation (cots, mattress, bedsheet, pillow, pillow covers) in the university hostels (men) free of cost. All are requested to carry their own blankets and lock & key. As per Covid protocol no one would be allowed to move outside the accommodation place except the field of play. University bus will be provided to carry the players from respective accommodation venue to FOP.

3. **Food** – As per AIU guidelines it is mandatory for all players/officials to take food at the dining hall in the accommodation venue. The food will be provided at a concessional rate by the caterer decided by the Organizing Committee. The cost of food & officiating charges will be collected at the time of reporting/ registration.

4. **COVID 19** – As per AIU/COVID 19 guidelines all universities must ensure that the athletes/officials should be **Covid 19 double dose vaccinated** or to submit **RTPCR negative report** (within 72 hours) at the time of arrival at the registration desk. Otherwise the athlete/official will not be provided accommodation in the campus or to participate in the tournament.

5. All universities **team managers** are requested to submit **quadruplicate (04) copies of Eligibility Proforma (attached)** of the players to the undersigned during the Manager's Meeting.

6. The Organizing Committee reserves all the right to change the venue and the date/fixture of the matches, if necessary. The last entries approved by AIU will be accommodated in place of absentee's universities. The decision of the committee shall be final and binding.

7. All matches will be played under Basketball Federation of India rules as adopted by AIU and Organizing Committee.

8. Players are required to bring their Identity card of the Current session, duly signed by the Competent Authority. Umpiring/Officiating charges shall be as per the AIU guidelines.

9. A meeting of all the managers of the team will be held on the evening of one day prior to the tournament, the venue and time details will be shared in due course of time. The fixture/schedule of the above tournament would be shared in the Manager's meeting. The date and time of the league matches will be announced after the completion of the knock-out matches.

10. Kindly ensure that your University has paid the Annual Subscription fees for the year 2021-22 and deposit the Xerox copy of the same if required.

11. Participating teams must bring their University Flag and it is mandatory to participate in the march past at the time of Opening Ceremony on the tournament date.

12. In case of misbehavior of any kind, KIIT authorities reserves the right to take any punitive action, even to the extent of cancelling the participation of the concerned University, escorting them off the campus and sending a report of the misconduct to the Vice Chancellor of the concerned University, copy to AIU for further action.
