A. He stressed the importance of CIQA in regulating the programs offered through Online Learning (OL). Additionally, he emphasized the need for continuous quality improvement and encouraged efforts to make additional programs available on the Online Learning platform for the benefit of students and society.

Minutes Of Meeting (MOM)

1.1 Review and approval of quality assurance mechanism for OL programs

The Centre for Internal Quality Assurance (CIQA) aims to establish a comprehensive and adaptable internal quality assurance system to deliver high-quality higher education programs through Online Learning. Its functions include:

- i. Identifying key areas where KIIT DU should maintain quality standards.

- ii. Overseeing the development of Study Learning Materials (SLM), integrating Information and Communication Technology (ICT), establishing Learning Centres, and coordinating with the parent institution and relevant regulatory authorities.
- iii. Promoting quality assurance by organizing seminars, conferences, and workshops.
- iv. Creating mechanisms to gather feedback from various stakeholders, analysing it, and recommending corrective actions.
- v. Holding periodic meetings with internal and external experts to ensure continuous quality improvement.
- vi. Ensuring the implementation of recommendations through regular monitoring and developing mechanisms for this purpose.
- vii. Encouraging the participation of all stakeholders—learners, teachers, staff, parents, society, employers, and the Government—in quality improvement processes.
- viii. Collaborating with Subject Matter Experts (SMEs) to enhance learner-centric education continuously.
- ix. The members agreed to the proposed mechanism and suggested reviewing it after one year.

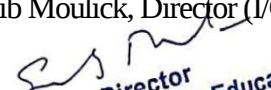

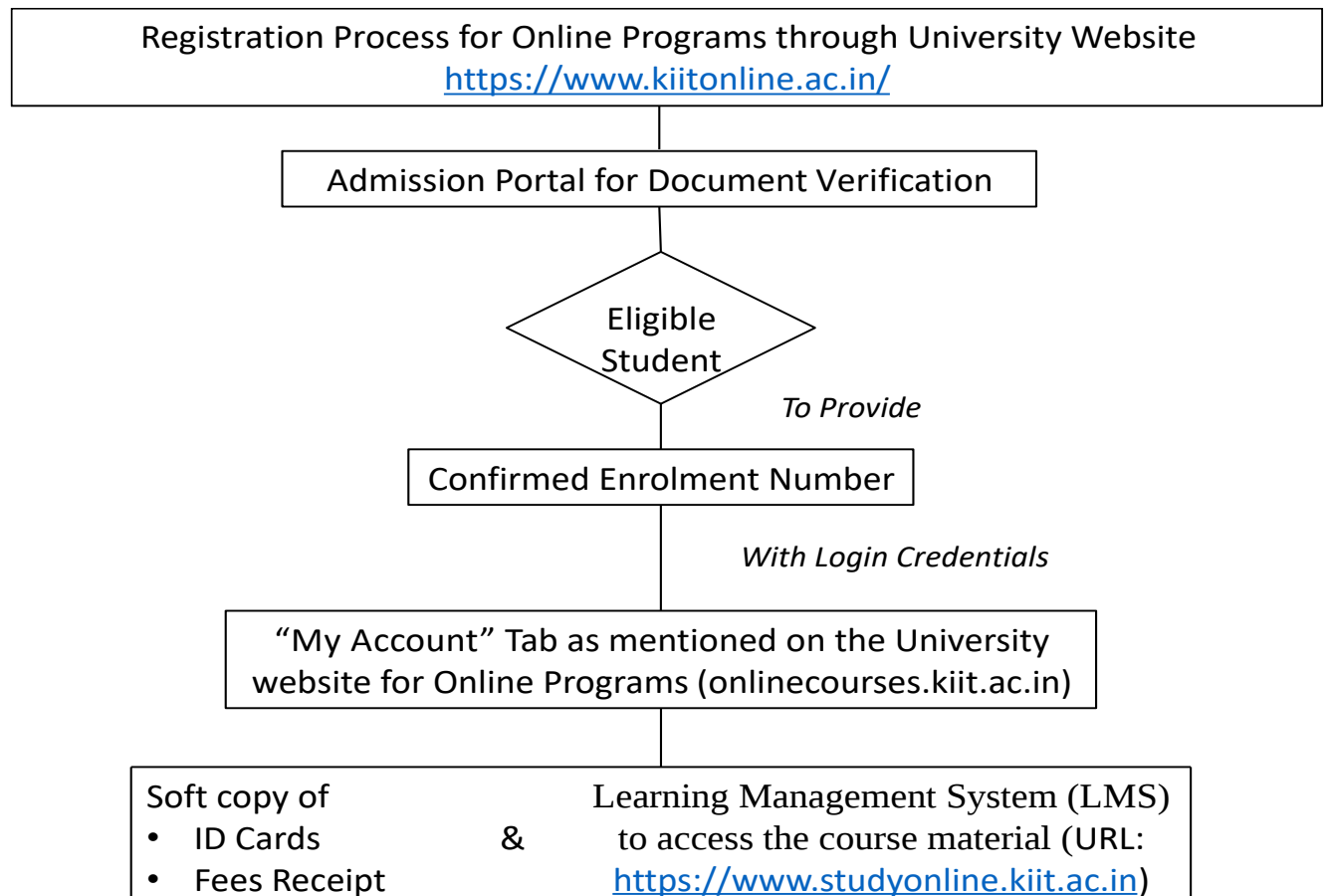
